She is a founding partner of Officina Economica per il Contenzioso e l'Antitrust, a firm in Milan that has been providing economic advisory services in antitrust, regulatory and civil litigation since 2018.

From 2004 to 2017, she is first Associate and then Partner at Luigi Prosperetti & Partners, a Milan-based consulting boutique specialising in antitrust and forensic economics, founded in 2000 by Prof. Luigi Prosperetti. Since 2011 she has been collaborating with ISPI School - Istituto per gli studi di politica internazionale, taking care of the course module "European Union: Market and Competition"; concerning the issue of antitrust damages.

She mainly deals with competition and industrial economics, and in economics applied to civil litigation. She has extensive experience as an economic expert in antitrust cases before the Italian Competition and Market Authority (AGCM) and the European Commission, in cases of abuse of dominant position (mainly in the pharmaceutical, telecommunications, energy and logistics sectors), cartels (in the banking, finance, insurance, telecommunications, gaming, packaging and consumer goods sectors) and mergers (in the banking, telecommunications and beverage sectors, as well as sales networks).

Finally, she has long experience as a technical expert in civil litigation in antitrust infringement (telecommunications, postal services, television and entertainment, oil, consumer goods and leisure sectors), intellectual property rights (pharmaceutical, new media and luxury goods sectors), contract-related liability (insurance, media, publishing, internet services, real estate and fashion sectors) and in non-contractual liability proceedings (pharmaceutical, banking, sports and consumer goods sectors).
